

# **Cedar River Trail: 42nd St. Crossing**



ver the summer of 2015, a cooperative project between the Canadian National Railroad and the City of Cedar Rapids made the Cedar River Trail intersection safer at 42nd Street. The CRT was realigned in conjunction with improvements made to the northbound off-ramp from Interstate 380/27. The new alignment allows for greater visibility for motorists and trail users at the road crossing. At the same time, the Canadian National Railroad installed gates at the rail crossing to reduce accidents. At the completion of the project new bicycle lanes were painted on 42nd St. from Center Point Rd. to Interstate 380.

In the summer of 2016, the City of Cedar Rapids will replace pavement, water mains and storm sewer on 42nd St. from Interstate 380 to Wenig Rd. NE. After the completion of the road improvement project, the city plans to add bicycle lanes continuing from Interstate 380 overpass to Wenig Rd.

# **Cedar River Trail: Tait Cummins Park**

In December 2015, the Cedar River Trail south of Tait Cummins Park was closed due to construction associated with the Prairie Creek Sanitary Sewer Reconstruction project. As part of flood alleviation, the sewer is being replaced from J St. to the Cedar River. A section of Cedar River Trail north of the Union Pacific Railroad Overpass was temporarily removed. As a result of the sewer reconstruction, Tait Cummins Park will feature a new parking lot and new wetland flood mitigation area. The trail should reopen in the spring.



# Sac and Fox Trail: Realignment

he goal of the Indian Creek Sanitary Trunk Sewer project is to replace the current aging sanitary sewer infrastructure and reduce potential sewage backups near Indian Creek. The sewer reconstruction is a joint project between Cedar Rapids, Marion and Hiawatha. It will allow for future growth of Cedar Rapids and surrounding communities. The entire project has three phases.

In 2013, the initial phase from the Bertram Rd. trailhead to Rosedale Rd. was completed.. One of the goals of the project is to re-align the trail out of the current flood plain. This current section of trail does not dry very well and every 3 or 4 years Indian Creek



experiences major flooding that damages the trail. An extension of the easement would be necessary to move the trail out of the flood plain. The city is working with adjacent landowners in acquiring a larger easement to realign the trail. In 2015, the Linn Area Mountain Bike Association completed Phase 1 of the Sac & Fox Singletrack project. The construction of an intermediate singletrack parallel to the existing trail allows for a new experience for bicyclists.

The second phase, completed in 2015, was from Rosedale Rd. to Wilder Drive. In the second phase, the trail was not used for access. With a wider valley, a new access road was constructed out of the flood plain for construction equipment. As the result, the Sac and Fox was realigned.

Phase 3 of the second segment will replace the sewer from Wilder Dr. to an intersection manhole near East Post Rd. This section will begin in 2016. The trail will be closed periodically during the construction. The trail alignment situation is similar to the second phase, additional funding would be necessary to fund new trail construction out of the flood plain.

The Indian Creek Sanitary Trunk Sewer project takes in the consideration the potential environmental impacts of the construction. The project seeks to improve wildlife habitat, protect scenery and reduce the impact of tree removal. As part of the project, new trees will be planted at strategic locations and other areas replenished with native prairie seed mixes to restore some original the habitat.



# **Cedar Valley Nature Trail: Wolf Creek Bridge**

In September 2015, Synder and Associates determined that the Cedar Valley Nature Trail bridge over Wolf Creek, outside LaPorte City, was unsafe for use. The bridge is closed for use with no designated detour around. With the bridge nearly 100 years old, the wooden infrastructure of the bridge has decomposed. Long-term repair solutions involve the replacement of the timber approaches with steel beams and steel pile bents, retaining the existing steel beams and installation a new concrete deck with black vinyl coated chain link fence. The new features would improve the flow capacity of Wolf Creek under the bridge and add 30 to 50 years of additional life to the bridge. The estimate cost of the project is \$1.49 million dollars.



Another option is the total replacement of the bridge. An entire new 349 foot bridge would cost an estimated \$2.39 million dollars. The Black Hawk County preferred option might be the establishment of an alternate alignment for the Cedar Valley Nature Trail. A new alternate route would require cooperation between the Black Hawk Conservation Board, Iowa Department of Transportation and the City of LaPorte City. The Black Hawk County Conservation Board will be holding a special board meeting at the La Porte City Community Center, 301 First Street, at 6pm on Wednesday, October 28 to review and discuss options available related to the closing of the Wolf Creek Bridge. Closure of this bridge leaves a gap in the Cedar Valley Nature Trail since there is not a good option for a detour.

In late 2015, the first bridge north of the Gilbertville Depot, known as the E4 Bridge, on the Cedar Valley Nature Trail was replaced with a pre-fabricated steel bridge. The project will not be completely finished until the asphalt approach can be poured later this spring. # **Hoover Nature Trail: Johnson County**

In the early 1990s, the dissolution of the Chicago, Rock Island and Pacific Railroad led to the abandonment of its railroad line. At the time, the acquisition of right of way for conversion to a recreational trail, the Hoover Nature Trail, was the goal of many. In the end, a 24 mile recreational trail from Cedar Rapids to the Mississippi River would exist. The Hoover Nature Trail would be part of the American Discovery Trail.

Over two decades, the construction of segments of the Hoover Nature Trail have been few and far between. Most recently, Linn County Conservation hard-surfaced a 2.7 mile stretch from Cedar Rapids to Ely in 2011. The city of Ely completed a segment of trail through its commu-

nity in 2015. In 2016, Linn County Conservation will extend the trail from the city of Ely to the Linn/Johnson County line at Seven Sisters Rd. The section of trail from the Linn/Johnson County line to Solon has been named "The Missing Link."

In November 2015, the Iowa Department of Transportation's (DOT) State Recreational Trails Program awarded \$679,699 to Johnson County for the first phase of the Hoover Nature Trail in Johnson County. The funding will be used to construct nearly two miles of trail, at an estimated construction cost of nearly \$1.1 million, from Solon north to Polk Ave. The trail will traverse through the northern side of Lake MacBride State Park. Currently, a five-mile scenic multi-use trail exists along the lake from Solon to near the entrance to the park. Johnson County plans to create a "dual surface" trail with the existing chipped limestone trail adjacent to the new ten foot concrete trail. This dual design will exist for approximately .6 miles before the Hoover Nature Trail diverges to the north to continue toward Polk Ave. The construction will include a new bridge across Mill Creek. This will require the removal of the existing abutments of the old railroad bridge and will provide a picturesque view of Mill Creek as it flows into Lake MacBride.

As part of the project, a trailhead at the Solon Nature Recreation Area will be constructed to provide visitors information about the locations of amenities available in Solon. In addition, a small rest area will is planned at Gaddis Pond. This area will contain seating and bike racks. Construction of the first phase will occur in 2016. The section from the Linn/Johnson County line to Solon is 5.8 mile with an estimated total project cost of \$4.3 million.

In October 2015, Johnson County received \$450,000 in funds from the Federal Recreational

Trails Program for its second phase of the Hoover Nature Trail. The 2.6 mile section from Seven Sisters Road to the Ely Road Underpass received 23% of its total project cost of \$1.95 million dollars. The County will continue to pursue additional funding of the section phase this year.


